

Eligibility Requirements

Applicants must be a **Tualatin Valley Water District** business, industry, government, or multi-family housing customer with a current water account in good standing.

NOTE: City of Sherwood, Southwood Park Water District and Valley View Water District currently DO NOT qualify for this rebate.

- Prior to approval, an on-site inspection may be required by TVWD.
- TVWD will send an approval letter within two weeks after we receive your application. Customers may apply for the rebate up to 90 days after efficiency upgrade or measures have been installed or implemented as documented by the invoice receipt.
- Send a copy of your sales receipt or invoice to TVWD. The total rebate will not exceed 50% of the total project material cost or \$1,000, whichever is less. Upon receipt of the paperwork, allow 4-6 weeks for processing.
- Rebates are for newly purchased products only. Labor and pre-existing products and services exceeding the 90 day post installation limit **are not** eligible for a rebate.

How To Apply

- Verify that your property is located in the TVWD service area.
- Have your cooling system inspected by a licensed service contractor. Work with your contractor to determine whether your system can benefit from new sensors and/or control measures.
- Completely fill out this rebate application form and mail a copy to TVWD at the address below.
- Have your contractor or maintenance provider install new equipment according to manufacturer's specifications.
- Have your contractor fill out the "Contractor Verification" section.
- Mail all paperwork, including the original application and copies of sales and service receipts to TVWD.
- Completed form and receipts must be submitted within 90 days of product installation.
- You may be contacted by TVWD to schedule an inspection of your system and upgrade to verify installation before a rebate will be issued.
